## ADOPTION AGREEMENT

BY SIGNING BELOW I AGREE TO ABIDE BY THE FOLLOWING:

1) HOUSING: Adopted horse must be received into 5 1/2 or 6 foot tall horse safe panels. If horse is gentled, it may be released into pasture with horse safe fencing. No barbed wire, trash etc. Horse must have adequate shelter from the weather.

2) CARE: Applicant is responsible, financially and otherwise, for all care and maintenance of the animal after it is received. This includes proper feed and nutrition, regular worming, annual vaccinations, consistent farrier work, grooming and regular vet care. SPECIAL NEEDS: \_\_\_\_\_

3) LIABILITY: Applicant is responsible, as provided by law, for any personal injury, property damage or death caused by adopted horse. Applicant is responsible for pursuing a horse that has escaped and is responsible for any costs incurred in recapture. Adopted horses found to be Running At Large are subject to removal by agent, thus voiding this contract.

4) TRAINING/HEALTH: Horse is being adopted 'as is'. Any necessary training is to be provided and paid for by the applicant. Any health issues the animal may be found to have is the applicant's responsibility. Any KNOWN health issues have been disclosed, and we urge you to consider a vet exam prior to adoption, at your expense. EXAM WAIVED? \_\_\_\_\_

5) TRANSFER OF OWNERSHIP: This is not a responsibility to be taken lightly. An adopted animal is a commitment, not an investment. If you are unable, for any reason, to keep the horse, you MUST contact us immediately. Strawberry Mountain Mustangs reserves first right of refusal for buy back. Do not sell or dispose of the animal before checking with us. Absolutely NO AUCTION SALES! INITIAL \_\_\_\_\_

7) BREEDING: If adopted horse is an unaltered male (stallion) applicant agrees not to breed the animal and to have him gelded within a reasonable amount of time - not to exceed 6 months. If the adopted horse is a mare, please use care and common sense. PLEASE HELP REDUCE THE NUMBER OF UNWANTED HORSES! If you want a foal, ADOPT!

8) MALICIOUSLY OR NEGLIGENTLY INJURING OR HARASSING THE HORSE IS FORBIDDEN AND WILL BE REPORTED FOR PROSECUTION.

9) BREACH OF CONTRACT: Should agent find that any of the above provisions are breached by the applicant, the horse is immediately subject to removal and this agreement is then void. Applicant acknowledges that the agent (or their representative) may enter onto the property where the horse is kept for purposes of removal, and applicant is responsible for any and all attorney fees and court costs incurred by agent to enforce this agreement.
